Methodology

Public Opinion Survey

- N=2,000 likely voters nationwide
- Balanced to U.S. demographics by gender, age, race, income, political ideology, and health coverage
- Conducted by LSG online May 18-26, 2023
- MOE: +/-2%

Key Findings

- A majority of likely voters are **SATISFIED** with our country's current health insurance system overall, and an even larger majority are **SATISFIED** with their current health insurance plan.
- The most popular reform proposal remains building on and improving our current system.

 Meanwhile, a majority do NOT support the public option or Medicare for All.
- Most likely voters do **NOT** trust the federal government to design and manage an effective health insurance plan that meets the needs of all Americans.
- A majority would be **LESS** likely to vote for a lawmaker who supports creating a new government-run health insurance system funded by higher taxes or cuts to doctors and hospitals.
- Most believe it is **IMPORTANT** for the federal government to increase funding for mental health services and believe the need for mental health care will **INCREASE** over the next decade.

Extend Affordable Care Act (ACA) subsidies. We should permanently extend subsidies for those who are uninsured to more easily afford health insurance through the public marketplace	56%	74%	56%	33%
Medicare buy-in. We should allow Americans aged 50-64 to purchase health insurance through Medicare.	56%	64%	56%	45%



Least supported proposal: repealing the ACA

<u>Government spending.</u> It would increase our national debt and deficit further.	26%	19%	25%	35%

More believe the private sector's response has been MORE adequate than the federal government's response
